Do we have our masks with us before we go out; gloves? sanitizer? Should we go out? Wiping off groceries - UGH! No summer camp - bummer. Swim in a pool.... think twice. Let's go see Grandma and Grandpa...NOT. It can all become quite exhausting and discouraging.

Hello All,

After careful consideration of recommended and suggested guidelines by the SNEUCC and others, the Ad Hoc Pandemic Team has made the decision to continue suspending use of the church buildings (Main Building and Wolcott Building) through December 31, 2020 for any gathered group that currently utilizes church space (UCW, Xmas Fair, Historian Archive/Photo Team, CE, and Sewin4Servicemen), and, of course, includes in-person worship services.

This is a holistic, moral, ethical and historic decision based on the common good of all and many other factors. We realize this comes with some disappointment, not least of all our own.

All church activities, including on-line worship via zoom, Chapel Chat, and other offerings will continue as scheduled.

Thank you in advance for your prayerful cooperation, understanding and patience as we care for each other and our neighbors during this uncertain time.

Our church community remains very dear to all of us. The goal is to preserve us. Thank you for walking with us on this task and supporting the efforts to be safe.



Historian's Column

We are in a new time of change. We are on the verge of the easing out of sheltering. We are in the first phase of a slow planned restart of a life like what we knew before the

Coronavirus invaded our society. The world-

wide spread of the COVID-19 changed much in how we have done business; protected our citizens, especially the frail. The stay at home orders affected businesses, schools, organizations including houses of worship, all aspects of our lives and our availability to be physically close to family and friends. Experiences have included on-line schooling, virtual worship services, shopping online, special hours for the elderly and frail to go to grocery stores, curbside pickup from the stores and restaurants that are open, to try to keep the customer safe.

People have experienced loneliness; grief over loss of freedom; shortages at groceries stores; worry and fears. These have been intensified by the constant broadcasting of reports, predictions and listing of numbers. We don't know what the lasting changes in society will be, but on our way to it, the people in our government, ministers and church leadership, school boards and many others are making some hard decisions. They are considering very complex issues.

Most of us are sheltering in our homes away from the debates about all aspects of our society. Some very complex decisions will need to be made regarding having a worship service: Can we do communion in any form? Can the choir sing (they stand too close together)? Can the congregation even consider singing since doing so spreads the virus farther and it is breathed in more deeply? How do we provide bulletins for the service and keep distancing in place? How do we dismiss the gathered congregation safely? Many in our congregation are elderly or frail. Based on multiple resources, including SNEUCC, the Ad Hoc Pandemic Team has made the decision to wait until January 2021 before holding in-person worship or Church School in our buildings. We shall surely celebrate when we can once again gather in-person.

This moment in our history will become just a small part of our church's story.



Missions Update

Our Missions Committee continues their hard work and outreach during these difficult times. Checks for \$250 each were recently sent to the South Windsor Food Bank, MACC, Cornerstone and Foodshare. A check for \$100 was sent to the UCC RIP Medical Debt Donation program which will bring \$10,000 of medical debt relief to people in the greater Springfield/Hartford/Providence area. We have also partnered with Wapping Community Church to collect much needed toiletry items for the South Windsor Food Bank. These mission donations are hugely appreciated and needed during this pandemic.

Church Committee

Jean Jackson, Church Clerk

Church Committee hasn't met formally as a group since March, when the COVID-19 pandemic struck. Treasurer Lee Anderson and Investment Guru Jim Belknap have continued to email the group with financial updates. The following would have been presented at April's meeting.

- Treasurer's report for March - Expenses were \$24,511.16. Income was \$35,725.33. Cash on hand is \$14,127.80. Surplus for March is \$11,214.17; surplus for the year-to-date is \$185.30. Lee noted that income was high due to a planned quarterly withdrawal in addition to \$12,000 in principal taken from the brokerage account to cover expenses.
- Investments - March saw the account decrease approximately \$162,000.00. \$34,397.00 was taken out to cover expenses, resulting in a total decrease of \$197,228.00 for March. The end value for March is \$1,401,076.28.

The following updates would have been presented at May's meeting, which was also cancelled due to the COVID-19 pandemic.

- Treasurer's report for April - Expenses were \$17,866.66. Income was \$11,485.00. Cash on hand is \$7,778.36. Deficit for April is \$6,381.66; deficit for the year-to-date is \$6,164.14. Lee noted that \$8,000.00 was withdrawn the brokerage account to cover expenses.
- Investments - April saw the account increase approximately \$145,284.00. \$8,000.00 was taken out to cover expenses, resulting in a net increase of \$137,284.00 for April. The end value for April is \$1,538,359.55.
- **The next Church Committee meeting will be held via ZOOM on Tuesday, June 9, 2020 at 1:00 pm.**
